


Passenger Location History

We store location history for your trips to:

- Suggest destinations for your next trip.



Driver Location History

We store location history during app use to:

- Suggest optimal working times and areas.
- Facilitate dispute resolution.
- Provide evidence in the event of a safety or security breach for our driver, their passengers or a third party.



Passenger Payment Details

We store your payment details to:

- Make payment faster for your next trip.



Driver Bank Details

We store your bank details to:

- Make a weekly payment for all of your completed trips.



Contact Details

We store passenger and driver contact details to:

- Enable you and your allocated driver/passenger to use our messaging and/or calling service to contact each other during your trip.
- Send receipts for your trips.
- Send information about our new features and special offers.



Passenger Targeted Advertising

We occasionally deliver targeted advertising during trips based on your demographic, location or trip history to:

- Direct you to places of interest whilst travelling in new places.
- Provide you with special offers from third parties.



Passenger Rating

We give you a rating based on your history of making and/or cancelling trips as well as feedback from your drivers and use it to:


- Share the rating with your drivers.
- Adjust the price we charge you.
- Prioritise your ride allocation.
- Monitor compliance with our community standards, alert you to violations and, as a last resort, revoke your membership.



Driver Rating

We give drivers a rating based on your history of completing and/or cancelling trips as well as feedback from your passengers and use it to:

- Share the rating with your passengers.
- Adjust the price we pay you.
- Prioritise your ride allocation.
- Monitor compliance with our community standards, alert you to violations and, as a last resort, revoke your membership..



Passenger Music Service Integration

We can connect your music service to a driver's audio system to:

- Allow you to play music of your choice during your trip.



Highway Authority Data Sharing

We share anonymised, aggregated analytics on trip patterns with selected local highway authorities to:

- Enable analysis of traffic behaviour and accidents on their highways.
- Enable ongoing research on smart city systems.
- Integrate with and optimise local transport systems.



Passenger Contact List

We access your contact list during a trip to:

- Enable fare splitting with friends.



Accident Detection System

We monitor both the driver and passenger locations and gyroscope data whilst in transit to:

- Alert emergency services in case of an accident.
- Store data in the event of an accident and share this data with the police, legal advisors and/or insurance providers at their request.



Community Standards

Our passengers and drivers must meet these community standards to continue using the service:

- Be polite to other service users.
- Conduct yourself in a safe manner.
- Do not discriminate against other service users on grounds of age, gender identity, relationship status, disability, race, nationality, ethnic or national origin, religion, belief or lack of religion/belief, sex and/or sexual orientation.



Pricing & Payment Algorithm

We use a pricing and payment algorithm to:

- Incentivise drivers to pick-up passengers during peak times.
- Encourage distribution of drivers to areas with passenger demand.
- Reward users who maintain good ratings with lower prices.



Trip Distribution Algorithm

We use a trip distribution algorithm to:

- Prioritise drivers and riders with good ratings.



Laws & Regulations


